### NELSON MANDELA BRIDGE CLOSURE

**26 July 2016**  
**For immediate release**

The **Johannesburg Roads Agency (JRA)** is advising motorists and pedestrians that there will be road closures at **Nelson Mandela Bridge** and **Carr Street** and **Bertha Street** and **Smit Street** due to **The Sun International CEO SleepOut** event. The closures will commence at the following times:

1. 20h00pm on the 26th/07/2016 until 05h00am 28th/07/2016
2. 06h00am on the 28th/07/2016 until 06h00am 29th/07/2016
3. 09h00am on the 29th/07/2016 until 05h00am 30th/07/2016

Safe pedestrian access will be maintained at all times along Nelson Mandela Bridge for the duration of the event except on the 28<sup>th</sup> when a temporary detour pedestrian route will be created along Biccard Street.

This event has been approved by **JRA** and **Johannesburg Metro Police Department (JMPD)**. Access to emergency services will be maintained at all times along the bridge.
