1. PURPOSE

The purpose of the Request for Quotations is to appoint a service provider for the Provision of Refurbishment at the Johannesburg Roads Agency Asphalt Plant.

2. SCOPE OF WORK –SPECIFICATION

Provision of Refurbishment

- Appointment of a service provider to upgrade the outside Kitchen at Asphalt plant depot as per the provided specification and drawings.
- The service provider to re-paint exterior building walls, steel palisade fence including gate, Window frames and door's (Steel and Timber) and painting of carport steel poles and supports.
- Remove existing and installation of new boom gate.

Service provider's rates to include the following when pricing for painting of exterior walls, steel palisade and steel poles:

- Wash the exterior walls
- Scrap off loose paint
- Sand rough spots using sand paper or similar approved product.
- Fill and repair open cracks, holes, chips etc.
- Applying of water based primer (1st Coat)
- Applying of 2nd coat (Final coat) using weather guard paint.

Annex B: CERTIFICATE OF INDEPENDENT BID DETERMINATION

1. This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
